The tenders are invited in terms of the Preferential Procurement Policy of 2017. A preferential point system shall apply whereby this tender will be awarded to a bidder in accordance with the Preferential Procurement Regulations, 2017 that was promulgated by the Minister of Finance on 20 January 2017 in Government Gazette No 40553 and as defined in the Conditions of Tender in the tender document, read in conjunction with the Municipal Finance Management Act, 2003 (Act No. 56 of 2003) Supply Chain Management Policy Regulations. It will be evaluated on functionality and the point system that will be applied is 80/20 (R50 million and below), relating to price and preference points respectively and as is fully described in the tender document.

Bidders must have the necessary skills, experience and capacity to complete and commission the Works successfully in terms of the tender documents and to the required standards.

Bidders must be registered with the CIDB in a CE class of construction works and have a grading designation equal to or higher than that determined in accordance with the sum tendered or a value determined in accordance with regulation 25(7A) of the Construction Industry Development Regulations, 2004. It is estimated that bidders will need a grading designation of **7CE or higher**.

Tender documents will be obtainable after 11h00 on 12 April 2019 from the offices of Ngaka Modiri Molema District Municipality, Cnr Carrington and 1st Avenue, Mahikeng Industrial Site. Documents will only be issued upon payment of a non-refundable deposit of R2,650-00.

A **compulsory briefing session** will be conducted on **24 April 2019** and prospective bidders are requested to meet the Employer's Agent at 10:00 at the entrance to the Sannieshof Wastewater Treatment Works. The Compulsory Briefing Session and Inspection are **compulsory** and tenders from Bidders that did not attend the Site Meeting and Inspection will be invalid.

The validity period for this tender is 90 days.
